Dear Ms. Kirchgessner:

This letter is on behalf of several groups (Habitat 2020, ECOS, Friends of Stone Lakes National Wildlife Refuge, and the Sierra Club) reviewing the DEIR (Draft Environmental Report) for the California Northstate University Medical Center Project.

We are requesting an additional 30 days to continue our review of this DEIR and feel that this is more than justified given that the City of Elk Grove needs to be in compliance with the record preparation requirements of AB 900 which requires that all documents that will be part of the public record will be provided by lead agencies within five days of being received and that they will be in an easily accessible electronic format. This has not been the case with other public comments being difficult to find and access, the DEIR and supporting documents only being reviewable after a massive computer memory consuming zip file download, and not all "Other Project Correspondence" being provided, with the last correspondence being from way back in May.

Please correct these deficiencies and provide an additional 30 days after they are corrected for public review of this DEIR.
